Telehealth

Our credentialing policy includes additional guidance for the provision of telehealth services to our members.

Provider Type	Criteria
Telehealth In-network provider (Louisiana-based)	Must be in the process of completing or have completed standard credentialing and contracting according to provider type
	Must be employed or affiliated with a physical practice or group located in Louisiana that participates in same network
Telehealth Out-of-state provider (With a Louisiana-based practice affiliation)	The out-of-state telehealth provider must be employed or affiliated with a Louisiana-based group or entity
	The Louisiana group or entity must be in the process of completing or have completed standard credentialing and contracting
	Must have a Louisiana state license as required for specialty OR have a Louisiana telehealth permit by the Louisiana State Board of Medical Examiners, if not in possession of Louisiana state license
Telehealth Out-of-state provider (Without a Louisiana-based practice affiliation)	Must be credentialed and contracted by another Blue plan
	Can be individually credentialed/contracted or part of a group or entity that is credentialed/contracted with the out-of-state Blue plan
National telehealth solution/vendor	A national telehealth solution contracts directly with Louisiana Blue to offer members telehealth services accessible in the home plan region and outside of it to ensure access while members are out of their home plan area
